

## TERMS AND CONDITIONS

### WIN A TELLY

1. Information on how to enter the Win a Telly forms part of these terms and conditions.
2. The "Promoter" is Murrumba Downs Shopping Centre, ABN 59 734 586 305 of Corner Dohles Rocks Road and Goodrich Road West, Murrumba Downs, Qld. 4503
3. This promotion is only open to Australian residents aged 18 years and over.
